



Privacy Terms and Policy

Satya Devi Foundation, here in referred to as SDF on this site, is exempt from taxes under section 80 G (5) (VI) of Income Tax Act of 1961. It is a non-profit organization dedicated to ensuring the privacy, confidentiality, and security of its donors and visitors. The following statement describes our information collection practices and how we use and protect your personal information. This statement applies only to data collected on web sites.

Satya Devi Foundation is a charitable organization for the benefit of underprivileged class of society advancing education and health (refer to our website). To protect your online payments, we use a secured site to ensure that account information is secure and that electronic payments are processed safely and efficiently.

Disclosure of Information

We request the donors who make donations on the site provide information such as their full name, address, telephone number, and email address. If you wish, you may provide additional information. Your information is needed for SDF to maintain contact with you.

SDF will not disclose personal information to anyone except when compelled by legal process or law enforcement and when asked by a court of law to do so. The information collected on this web site will not be sold or transferred to any third parties other than the secured site for the purpose of processing the transaction you are authorizing and to use the information needed for that purpose, and on occasion to authorized vendors to provide services to donors and prospects.

Application of Funds

SDF has under their policy has requested to donate as under:

- A) The member is a permanent member who agrees to pay an annual subscription of a minimum of Rs1000 or its equivalent in foreign currency, which becomes a part of the corpus and the income generated by this is used towards upliftment of the underprivileged class of society. Trustees, however, have the right to amend policy at any time.

- B) The donations of one time donors will be used as per foundation objectives and the regulations of Income Tax department of government of India.

- C) A donation made under the sponsorship scheme of the foundation will be applied to the candidate sponsored by the donor and a breakdown of expenses will be provided periodically

Refund Policy

Satya Devi Foundation's mission is to assist less fortunate children in pursuing their education, higher studies after school, and participating in extra-curricular activities. Educating children with member contributions and donations from philanthropic donors is the goal of the foundation. Contributions to the foundation are exempt from Income Tax under section 80 G (5) (VI) of the Income Tax Act of 1961.

Donations to Satya Devi Foundations can be refunded under the following circumstances.

1. Donations made to the foundation by mistake and also change of opinion by the donors to claim back the donation.
2. Wrong payment of donations by members either for the amount of donation or the recipient of donation.
3. Satya Devi Foundation is unable to accept the donation for any reason what so ever.

A refund request for part or all of a donation can be made up to 30 days after the date of payment and an undertaking must be provided that no income tax relief is claimed on the donation.
